MEMBERSHIP AGREEMENT FOR INSTITUTIONAL AND AFFILIATE MEMBERS

The Organization below commits to become either an **Institutional Member** or an **Affiliate Member** of the International Institute for Energy Systems Integration (iiESI), a virtual institution realized through teams drawn from its Institutional and Affiliate Members.

The iiESI is a global community of scholars and practitioners from leading institutions engaged in efforts to further the understanding of complex energy systems and accelerate the transition to integrated energy systems that informs the energy dialogue and guides energy investment and policy decisions.

This Membership Agreement enables the iiESI to actively advance the state of market readiness for transformative energy systems in efforts to enable highly integrated, flexible, clean and efficient energy systems.

The iiESI was initially formed as a collaborative group among the National Renewable Energy Laboratory (NREL), Pacific Northwest National Laboratories (PNNL), Electric Power Research Institute (EPRI), University College Dublin (UCD), Technical University of Denmark (DTU), and University of Leuven (KU Leuven).

This Membership Agreement provides the following iiESI benefits:

- Participation and contribution to two to three internationally-focused meetings each year to foster exchange of ideas, exchange information on results, lessons learned, and best practices from ESI-related activities throughout the world.
- Access to and participation in iiESI online resources to aid continuing education in energy systems integration such as an internet portal that contains blogs, wikis and collaborative tools and a repository for data and research.
- Access to and contribution to a public framework for knowledge capture, management, and transfer from energy systems experiments conducted to date and in the future including access to and contribution of case studies and other materials for public consumption.
- Participation in educational programs, including opportunities for students and professionals such as week-long ESI intensive courses, on-line courses for professional development, internship programs, and ESI curricula and summer schools.¹

¹ Members cover own travel costs and in kind contributions for students and professionals time & expenses for participation in iiESI educational programs.

In addition to the iiESI membership benefits, Institutional Members receive the following:

- Institutional Members may hold decision making seats on the Executive Committee and employ a consensus decision-making process to develop the long-term strategic direction, governance structure, and operating plans for the iiESI.
- During the initial realization phase of 6-12 months, Institutional Members will serve on the Executive Committee. The process to determine the future role of iiESI Members on the Executive Committee will be developed and implemented by the Institutional Members within the first 6-12 months of iiESI's existence.
- In addition, Institutional Members receive formal recognition by the iiESI for their contributions. Attribution to the organizations which are Institutional Members and inclusion of the organization's logo will appear prominently on the iiESI web site, on all (general and activity-specific iiESI marketing materials), and in the iiESI Annual Report.

In addition to the iiESI membership benefits, Affiliate Members receive the following:

- Affiliate Members may serve on the Executive Committee to inform iiESI's long-term strategic direction, governance structure, and operating plans.
- In addition, Affiliate Members will receive recognition by the iiESI for their contributions. The organizations which are Affiliate Members will be identified on iiESI web site, and in the iiESI Annual Report.

Authorization to use iiESI Member's name and brand
